EVERYBODY NEEDS FOOD NEIGHBOURS ...

Once more Michael Lauricourt and his wife Mami, owners of the Old Cottage Coffee Shop since 2012, have stepped up to the mark to help vulnerable people, this time in the wake of the coronavirus pandemic.

The café was closed in March because of social distancing requirements in the COVID-19 lockdown and has only recently re-opened part time (outside only) from Wednesday to Sunday.

Instead of feeling sorry for themselves they found their reward in helping those in need. Councillor John Fahy gave them some names of people who were unable to get out because of health issues under the lockdown restrictions so they cooked and delivered free lunches three times a week for four months – with the help of local volunteers – to 20 elderly and vulnerable households in Charlton, Blackheath, East Greenwich and Eltham. They bought all their food from local shops in Charlton Village in a bid to support the local community.

At first they funded the lunches themselves, then somebody, who Michael prefers not to name, gave them a donation to enable them to continue. Sadly, that money has recently run out.

The community is the main focus of their lives for Michael and Mami, spreading goodwill and giving practical support to those they find who are in need of a helping hand. For instance, the café always provides Christmas dinner on Christmas Day for vulnerable people and donates any money left over to local charities.

When burglars got into the café and trashed it early last year the community rallied to their support and raised $\mathfrak{L}6,000$ in record time, via a crowd funding appeal set up by Simon Short, a regular customer. He paid tribute to them, saying: "The owners do so much for the community



and that's why people want to support them now... I hope seeing the responses to this awful thing shows them how much they are valued."

Michael and Mami's future at the café is safe for the time being, thanks to a small grant, that enables them to pay the rent up front. But there are difficult times ahead. And adding to those difficult times, Michael is grieving for his father, who died during lockdown – though from an illness unrelated to coronavirus.

To keep the show on the road, Michael and Mami have applied to the Trustees of Charlton House, to rent the café in Charlton House at the weekend until early next year. We need to keep their future safe.



CCRA FOOD BANK COLLECTION POINT

As lockdown saw the removal of Food Bank Donation boxes in supermarkets, CCRA stepped in to support the Greenwich Food Bank by running a pop-up donation point. While taking their daily exercise, residents have been delivering non-perishable goods to the garden of 59 Delafield Road (thanks to Jon and Julia) every Tuesday 2-3pm. As people come off furlough and start working reduced hours or having no job at all the Food Bank anticipates a massive increase in demand. Although food donation boxes have reappeared in supermarkets we will continue to run this pop-up for the time being. Could you spare a few items each week to support those who are struggling and less fortunate? Please make a donation, however small. Every little helps.


Welcome back!

Laura Miller remembers...

Laura was born in Greenwich on 6 April,1920, the sixth child in a family of nine children who lived in Glenister Road. She attended local primary schools, then Halstow Road Senior School and went to Sunday School at the nearby church.

She remembers her favourite game as a child was playing 'jacks' with friends and family in the back garden and often engaged in 'hopscotch' in the street, but she says she particularly loved dancing round

the Maypole. Laura, whose four brothers were deployed with the army during the war, was fourteen when she left school. She soon found work with local organisations including the Co-op.

Six years later, in December 1940, she married Jerry at Christchurch in Greenwich.
They spent their wedding night – and many more subsequent nights – in the air raid shelter at the bottom of their garden. In 1942, together with her parents and younger sister, they moved to Delafield Road. She has lived there ever since.

Jerry worked as a foreman in Johnson and Phillips, a cable work industry situated at the end of Delafield Road, subsequently taken over by Enfield Cables and the Delta Metal Company. They had one daughter, Geraldine.

During the 1960s the London County Council employed Laura to work in numerous schools within the Charlton, Greenwich and Woolwich areas as a play centre superintendent. Children could attend these supervised centres after school and during the school holidays, where they enjoyed numerous interesting activities including sports,

creative work, dance and drama.

Geraldine adds: "My mother was a great needlewoman and knitter. She made most of my clothes when I was growing up – including mini-skirts!"

Laura frequently travelled with Jerry both in the UK and abroad. They spent many happy holidays in Norfolk, and in 1947 especially enjoyed staying at a holiday camp called 'Potters' – a destination the family visited

frequently in subsequent years – probably better known today for its World Indoor

Bowls Championships.

She and her husband began travelling further afield in the late 1960s, which became especially attractive when their daughter took up teaching positions in Germany and Hong Kong.

Jerry sadly passed away in February 1994, approximately six weeks after they had both returned from an extended stay with Geraldine and David in both Hong Kong and Thailand.

Laura remembers enjoying

the original VE Day but believes she celebrated it in the Antigallican Public House in Church Lane. She was seven

months pregnant, and as a consequence was fortunate to be offered a seat for a few celebratory hours!!!

Laura says she thinks she has always been very fortunate with her neighbours in Delafield Road, and compared this year's VE Day celebrations with those she experienced for the Queen's Coronation in 1953.

She says it was good to 'touch base' with both old and new acquaintances and to raise a glass to celebrate the memorable occasion. Maybe the next cause for celebration will be the defeat of COVID-19!

Exercise Classes

Like so much else, the Monday morning exercise classes fell victim to the lockdown. Just two weeks into the selffinancing arrangements, where all costs including refreshments were covered by the charges, we had to abide by government instructions and close our popular class. We were very grateful to Joanne, our enthusiastic instructor, who provided us with exercise sheets and some equipment so we could continue our stretches and routines at home.

We know members are keen to get going again but can't yet provide a definitive new start date. Following government quidance, St Luke's have undertaken a detailed risk assessment of St Richard's Hall, and, given that exercising clearly needs more space than sitting in a meeting, the 2m distancing rule puts a cap on numbers. CCRA is doing its own assessment of other issues that need resolving before we could become fully Covid compliant. With the possibility of an increase in cases in the autumn, we will err on the cautious side before restarting the class.

Knit and natter

OK, so lockdown did stop the knit and natter group from 'nattering' but it certainly didn't stop the knitting.

Throughout lockdown the group continued to knit and in some cases it was knitting that got them through those long lockdown days. Being able to continue with our charity knits provided members with a sense of purpose and a calming therapy. Although the knits couldn't be delivered, we have built up a 'stash' of

goodies that will eventually make their way to the London Ambulance Service (toys), the neo-natal unit at the QE hospital (blankets and mitts) and Greenwich Homestart (finger puppets). When the group needed more wool they organised an outdoor wool swap to maintain social distancing. The group are grateful to RBG, the Co-op and Rowan wool for their sponsorship and whilst the group cannot, for the moment, meet face-to-face, the knitting will continue.



Playing Out

After months of playing indoors, children can now return to 'Playing Out' as CCRA's scheme is back up and running. Playing Out sees

Sundorne Road closed every other Wednesday (3.30pm onwards) to allow children the opportunity to experience street play. The scheme has some new Health and Safety rules to ensure it is Covid 19 compliant and anyone who wants to come along is strongly advised to read our guidelines – see https://www.charltonresidents.net.

To participate in Playing Out you will need to follow these instructions and be prepared to provide Track and Trace contact details. The first session took place on Wednesday, 12 August and it was a great success. The children were able to meet up with friends they hadn't see for months and much use was made of the 'super-soakers' on a blistering hot day. Everyone agreed that even with new rules in place it felt like a bit of 'normal'. We look forward to seeing you and your children at any of the following sessions: 23 September; 7, 21 October; 4, 18 November; 2, 16 December. Book Group

We have continued to meet during lockdown and kept in touch by Zoom, with a few book-related quizzes thrown in for good measure. We've now made some tentative steps towards meeting face to face, supported by social distancing, but we feel we need to limit our numbers until the CV19 situation is much clearer or we know what a 'new normal' looks like. In the meantime, we'll be posting news of our books and comments.

We've just finished Where the Crawdads Sing by Delia Owens which we found to be an 'easy read' with interesting science/biology references and descriptions of the swamps in North Carolina. The book painted a rich and sensitive picture of the lives of shunned 'outsiders' in a close-knit community where blame is based on years of prejudice and lack of understanding we particularly liked the twist at the end ... This book is about to be made into a film by Reese Witherspoon, and is described as a murder mystery - we recommend the book!

Our next book is Year of Wonders by Geraldine Brooks which describes a single village's response to the plague in 1666 when a Pennine village of 350 souls confronts a scourge beyond remedy or understanding. We felt this book would be topical in some ways but also one to help us put CV19 behind us.

Walking group

I have been lucky enough not to need to self-isolate for the last few months and had time to explore some of the amazing natural areas on our doorsteps. One delightful rediscovery was Woolwich

Common. It once offered local people grazing and fuel rights but in the early 1800s it was taken over for military use. If you've been familiar with the area for many years you will have noticed how the Common has changed.

Woolwich Common is made up of mostly rough grassland but also some acid grasslands providing characteristic vegetation in each area. In the south west corner, however, hidden away behind bushes, shrubs and trees, is a distinctive, circular area with reeds growing. This is the remains of a reservoir built in 1848 by convicts from the prison hulks on the Thames moored off Woolwich. I remember passing this on my way to school in the 60s when it was covered over but very clearly on view. Since then a more natural look has been developed by the planting of trees and bushes, thus encouraging wild life such as birds, butterflies and foxes, evidenced by some very welltrodden fox-runs.

Please don't tell anyone about this oasis of peace and beauty as they'll all want to go – but just to celebrate the Walking Group's re-start I intend to take a hike there on Sunday, 13 September, then on to Severndroog Castle. Singing Group

We suspended all singing sessions from 23 March and have not yet been able to resume. Early in the course of the pandemic, it was thought that singing groups might be helping the virus to spread, endangering their members.

However, the current view seems to be that it is the volume of your voice, rather than whether you are singing or talking, that makes the difference. So perhaps we can get together and sing quietly! However, amateur singing groups still have to follow government rules on meeting people from outside our own households. Obviously we are all missing the opportunity to get together and sing, and we'll keep you up to date with any further developments.

Music Group ('SE7')

The group last played at Cattleya on 15 March just before the lockdown. The St Patrick's Night event and the CCRA Spring Social were both cancelled, and we are still waiting for our next opportunity to play together. Although some of the restrictions governing amateur music-making were relaxed on 14 August, we still have to follow the general rules on meeting people from outside our own households - 6 people out of doors or 2 households indoors. Further relaxation is not expected before November, but we'll let you know as soon as anything changes.

Community Gardens

Two very successful plant sales held during the lockdown period meant that a substantial donation could be made to our local food bank. On Thursday 29 October Charlton Community Gardens will be holding a Family Learning Event from 10-12noon at Charlton Station. Should rules on contact make this inadvisable, we will again offer take-away bags with gardenrelated games and quizzes and bulbs to plant. Continuous footways come to Charlton

You may have wondered what the new road layout at the top of Victoria Way and at other junctions along Charlton Road are for.

New junctions, known as continuous footways, have been introduced. They are designed to encourage drivers to give way to pedestrians when turning into side roads, reinforcing Highway Code Rule 170.

The Council aims is to reduce car speed by imposing a 20mph limit and improve pedestrian safety along Charlton Road by creating continuous footways and removing parking at junctions.

RBG's Highways Team anticipate that it may take time for people to get used to the new arrangements claiming that research has shown these junctions do reduce accidents. They are monitoring the changes carefully and will act on recommendations from an independent road safety audit.

For more information visit https://bit.ly/3IGE8Zw However, the research cited by the council (which was undertaken in 2018) suggests that little more than half of all drivers gave precedence to pedestrians when turning right into a side road.

Pedestrians were safest when drivers were turning left out of a side road. This makes it clear that drivers need to be made more aware of the expectation that they give way to pedestrians while pedestrians need to take care when crossing on these continuous footways – don't just assume that drivers know and follow the Highway Code!



Reds reach crisis point!

A Shakespearean tragedy or a Brian Rix farce? Whichever way you look at it the situation at Charlton is dire. After suffering the misery of Roland Duchatelet's parsimonious regime for years, fans can be forgiven for thinking the club had been rescued from mediocrity and looked set for a bright future.

How wrong can you be? Since then the Duchatelet period seems like an oasis of stability and sense. Now the club is faced with possible closure as a number of potential owners bid to takeover. Who are they? No one really knows as the EFL and club officials keep the faithful in the dark.

We thought the takeover by Abu Dhabi businessman Nimer Tahnoon was going to save our club, pump substantial funds into the coffers and set us on a course for the premiership. That's what he pledged. But it was all piecrust promises – easily made and easily broken. He installed Matt Southall as chief executive of East Street Investments, a company set up to run Charlton. But it turned sour as they embarked upon a very ugly and very public row over use of funds that ended with police being called to the Valley over fraud allegations.

During this dispute businessman Paul Elliott stepped in and performed a consortium takeover. Was this the solution to Charlton's problems? Ever since there have been rumours ricocheting round the Valley leaving us in the dark. A statement by club director Marian Mihail in August left us no clearer about the future. He confirmed

that several interested parties were trying to buy the club but could not reveal who. He also said several potential owners and directors of ESI had applied to the EFL to be involved but the EFL had rejected them. Why? We don't know but it cannot be good that people trying to run our club don't meet EFL criteria.

In the meantime other people are looking at the club. Of these the most interesting is Danish millionaire and rock star Thomas Sandgaard the CEO of Zynex a medical technology company with an annual turnover of \$40 million.

He has looked at the several clubs and decided Charlton represents the best chance of success. He believes we should be back in the premiership. Don't we all?

Oh, yes, and on the pitch it's been disaster too! There is a tiny glimmer of hope. Sheffield Wednesday have received a 12 point penalty for breaching spending rules and, if imposed, it would put them below us in the table on final reckoning and keep us in the championship. The decision was made by an independent disciplinary commission that decided not to introduce the penalty until next season. Charlton have appealed to the EFL and Sheffield are also appealing the decision.

In this maelstrom of mismanagement, Lee Bowyer, ably backed by Steve Gallen, is trying to rebuild his team. With Taylor gone and others heading off and no assurances of a revenue source it's going to be a very long season.





Planning inquiry – inspector supports council masterplan

In early June the Secretary of State, Robert Jenrick, dismissed the appeal by Rockwell, declaring that their plan for part of Charlton Riverside "fails to take the opportunity to promote a high quality of design".

In supporting the Inspector's recommendations, he observed that the council's Masterplan for which we have been campaigning for years, is "well considered and robust".

He also rejected plans for the so-called Tesco 28 storey tower in the centre of Woolwich. This came shortly after he

was forced to withdraw his rushed approval for a scheme in Canary Wharf saving Richard Desmond, who sat next to him at a dinner, \$£45 million.

This is a huge victory for local people and Charlton Together who stood their ground and argued consistently around the basic vision and objectives, persuading first the council's planning board to reject their officers' recommendation, then likewise with Sadiq Khan at London level and then finally securing the broad support of the Inspector at the Inquiry in January.

Government plans to reduce local involvement in planning

This sounds incredibly dull and boring, but what is proposed could hugely impact on the lives of all of us.

Until the end of October, the Government is consulting on plans to scrap the basic planning framework first set up in 1947.

A White Paper, "Planning for the Future – August 2020" outlines "a whole new planning system for England", alternative arrangements designed to speed up what can be long and tortuous. In the process community involvement and local democracy will be severely curtailed.

All land in England will be designated under three categories; growth, renewal or protected.

In growth areas "land suitable for growth will be approved for development at the same time that plans are prepared, meaning new homes, schools, shops and businesses can be built quickly and efficiently so long as local design standards are met"

Councillors and the community will be involved in making the plan for each area and in agreeing codes and standards, but after that local democratic control will disappear.

There will be no planning board meeting to consider detailed plans: Council officers will have delegated responsibility.

So, for example, on a development like the Charlton Riverside, we would still be involved in drawing up the masterplan, but after that we and councillors would have no way of challenging any detailed plans, such as Rockwell's scheme we successfully opposed.

There are some sensible proposals to change ways in which planning procedures do need bringing up to date but an obsession with data and all things digital.

It won't surprise you to know that the changes will make us "a world leader in digital planning", able to sell our services to the world!

However, many, many housing experts see it as a developers' charter and very bad news indeed for social housing, not seriously addressed at all in the white paper which focuses very much on homes.

CO-LIVING IN CHARLTON CHURCH LANE

A planning application for what was once the Conservative Club in Charlton Church Lane is seeking permission for a development comprising '26 Co-living units'. What they are describing as a House in Multiple Occupation will contain very small single and double units with basic hygiene and some shared kitchen and outdoor space.

Units will be for rent for a minimum period of three months, in what the applicant says is "recognition of the growing trend towards purpose built shared living accommodation". There will be a concierge on site 24 hours and, an interesting touch, a bedding and linen changing service available, but they do admit what is on offer "is not capable of use as a self-contained home".

What is definitely a trend, unfortunately, is more and more people unable to find a self-contained home. Because of many concerns about what is proposed and the resulting objections it will now go to a planning meeting in due course. You can find the application on the council's website; code 20/1166/F.
